TRAINING AND SCHOLARSHIP GRANTS

A. SHORT TERM COURSES

These are short-term scholarship/training grants to qualified OFWs and/or their dependents aimed at enhancing their employability through provision of specialized skills upgrading courses in accredited training institutions

Under this are the following programs:

1. **Skills-for-Employment Scholarship Program (SESP)** - a short term (6 months to 2 years) training program consisting of a maximum of **Php14,500.00** per training course leading to completion of a **technical or vocational course in any school accredited by TESDA, MARINA, and other government training institutions.**
2. **Seafarers' Upgrading Program (SUP)** - a short-term training program for seafarers consisting of a maximum of **Php7,500.00** per upgrading course in accredited maritime training centers/institutions to ensure competitive advantage in meeting International Maritime Organizations competency standards.

For the first availment, a single OWWA membership contribution entitles a seafarer to a training course of his/her choice; subsequent entitlements shall be allowed every after 3 recorded payments of OWWA membership contributions.

3. **Information Technology Training Program (ITTP)** – a 5-day training program implemented both in-country and onsite by in-house IT personnel aimed at enhancing the skills of the OFWs or their dependents on the use of information technology. This includes the use of internet and training in Microsoft word, excel and PowerPoint to improve their computer literacy.
4. **Updating Management Level Courses (UMLC)** – a financial subsidy amounting to Php7,500.00 given to active OWWA member-seafarers (3rd and 2nd Mates, 4th and 3rd Engineer Officers) who need to undergo a management level program to be eligible for certification as management level officers (Masters, Chief Mates, Chief Engineers and 2nd Engineers).

B. DEGREE GRANTING

These are scholarship programs granted to qualified and deserving OFW-dependents who intend to enroll in any 4- to 5-year baccalaureate courses.

Under this are the following programs:

1. **Education for Development Scholarship Program (EDSP)** - a competitive scholarship grant to qualified dependents of OFWs consisting of a maximum of Php60,000.00 per school year until the completion of baccalaureate course (4-5 years). The selection of scholars is determined through the DOST national examinations. Only the top 200 passers are considered for the program.

2. **OFW Development Scholarship Program (ODSP)** - a scholarship program that offers financial assistance amounting to Php20,000.00 per school year to qualified dependents of OFWs who receive a monthly salary

of not more than US\$400.00, and who shall enroll in any four-year or five-year baccalaureate course or associate course in a state university/college or any school accredited by CHED.

3. **Education and Livelihood Assistance Program (ELAP)–Education Component** - a program for:
 - a. Dependents of deceased OFWs who were active OWWA members at the time of death*; and
 - b. dependents of OFWs who are/were incarcerated/convicted and meted out the death penalty in foreign countries who have at least 1 OWWA membership contribution.

A special benefit package intended to cover the continuous education of an eligible dependent until college, regardless of his/her preference. A maximum of **Php5,000.00 for k+elementary (kinder to Grade 6)**, **Php8,000.00 for high school (Grade 7 to Grade 12)** and **Php10,000.00 for college level per school year** is granted to the qualified dependent.

WELFARE SERVICES

I. WORKERS ASSISTANCE

A. In-country

Services include requests from families or next-of-kin (NOKs) for assistance in locating the whereabouts of missing OFWs, providing information and guidance, counseling and conciliation service.

B. Onsite

Services include psycho-social counselling, mediation/conciliation with employer, jail / hospital / worksite / campsite visits and para-legal assistance to OFWs who wish to pursue labor/welfare case against their employer in the host country.

II. REPATRIATION

The program is designed to facilitate the early repatriation of distressed OFWs to avoid affected workers from being stranded and left without means of ensuring their safety and sustenance. It consists of bringing distressed/sick OFWs, including the transport of human remains and their belongings, back to the country.

Emergency repatriation is carried out in the event of any political unrest or natural calamities. The components of

the program are the following:

- a. Provision of air ticket
- b. Airport assistance
- c. Half-way home accommodation
- d. Medical assistance/referral
- e. Domestic transport assistance
- f. Psycho-social counseling

III. REINTEGRATION

This involves the preparation of the OFW and his/her family for his eventual return to the country. The components of

the program are the following:

1. **Psycho-social component** consists of capacity building through assistance in community organizing and maintaining OFW Family Circles (OFCs), and services like psycho-social counseling, stress debriefing, values re-orientation and financial literacy.

2. **Economic component** consists of social preparation programs for livelihood projects or community-based income generating projects, skills training and credit facility or lending. At present, the economic component has the following programs:

- a. OFW Enterprise Development and Loan Program (formerly P2B OFW Reintegration Program) – is an enterprise development intervention of OWWA in partnership with LBP and DBP. It aims to help OFWs and their families in the establishment of viable business enterprises that will provide them with steady income stream and create employment opportunities in their community.
 - i. The **Enterprise Development Interventions** are social preparation activities that include the conduct of business appreciation seminar with entrepreneurial skills self-assessment, referral to partner institutions for project-specific skills-training or business-relevant orientation/seminar, referral to individuals/institutions for immersion, conduct of seminar on business plan preparation and other relevant interventions.
 - ii. **Loan Facility** – after the OFW-applicant has completed the **Enhanced Enterprise Development Training (EEDT)**, he/she can avail of the loan facility. **Loanable amount per borrower is Php100,000.00 up to a maximum of Php2M for individual loan borrowers and up to a maximum of Php5M for group loan borrowers.** A 7.5% interest rate per annum is fixed for the duration of the loan.

OFWs may avail of the loan facility within 3 years from the date of arrival to the Philippines, except in cases where the OFW-applicant has an on-going business prior to the time of application.

3. **Balik-Pinas, Balik-Hanapbuhay Program (BPBH)** - a non-cash livelihood support/assistance worth Php10,000.00 consisting of techno-skills and/or entrepreneurship trainings and starter kits/goods. It is intended to provide relief assistance to returning member-OFWs, active or non-active, who were displaced from their jobs due to war/political conflicts in host countries or policy reforms, controls or changes by the host government, or were victims of illegal recruitment and/or human trafficking or other distressful situations.

4. **Education and Livelihood Development Program (ELAP)-Livelihood Component** - a program designed for survivors of deceased OFWs who were active OWWA members at the time of death and families of OFWs who are incarcerated/convicted and meted out the death penalty in foreign countries. It is intended to provide, aside from financial assistance for the continuing education of a qualified dependent, a **livelihood activity in the amount of Php15,000.00** to surviving members of the family to augment family income.

5. **Balik-Pinay, Balikhanapbuhay (BPBH) Program** – provides training cum-production/employment intervention intended to bring improved socio-economic well-being of distressed women OFWs

- A. **Pre-Departure Orientation Seminar (PDOS)** - a mandatory orientation-seminar aimed to orient departing migrant workers with basic information that are most beneficial to them, e.g. work standards, general profile of the country of destination, stages of the OFW's life abroad, health & safety, travel tips, airport procedure, and government programs & services. The orientation-seminars are country-specific and in some cases, skill-specific.

- B. **Comprehensive Pre-Departure Education Program for Household Service Workers (CPDEP for HSWs)** - a mandatory orientation-seminar for departing HSWs to address the difficulty confronting the OFWs relating to language barrier, as well as the culture of destination countries. / **Implemented in 2007**

V. SOCIAL BENEFITS

A. DEATH AND DISABILITY BENEFIT

It is a self-administered Insurance Benefit Program for OWWA members. The death benefit, burial gratuity and disability assistance are integrated into one package of financial benefits.

The components of the program are the following:

1. **Death Benefit** - insurance benefit to survivors of deceased OFWs who were active OWWA members at the time of death. The beneficiary is entitled to **Php100,000.00** for deaths due to natural causes and **Php200,000.00** for accidental death.
2. **Burial Gratuity** - in addition to the death benefit, a funeral grant of **Php20,000.00** is given to the beneficiaries of the deceased OFW to assist them for the decent burial of their loved ones.
3. **Disability Benefit** - this could be availed of by the OFWs for any accident-related disabilities ranging from **Php2,500.00 to Php25,000.00 for partial disability** and from **Php50,000.00 to Php100,000.00 for total/permanent disability**.

B. SUPPLEMENTAL MEDICAL ASSISTANCE PROGRAM FOR OFWs (MEDplus)

MED plus is designed to provide supplemental medical relief for active OWWA and PhilHealth member - OFWs who are afflicted with dreaded diseases and were hospitalized, either at the jobsites or while in the Philippines. It is a financial assistance that aims to provide eligible avalees with relief in the payment of their hospital/medical bills that is equivalent to the PhilHealth benefits under its case rate system, but not to exceed **Fifty Thousand Pesos (PhP 50,000.00)** per member.

C. WELFARE ASSISTANCE PROGRAM

It is an assistance extended to OWWA members, active or non-active, and/or their families who are not eligible under any of the existing OWWA social benefit programs. It seeks to provide cash relief assistance to OWWA member and their families, whether at the job site or in-country, in any one of the following circumstances:

1. Calamity assistance for OWWA member and/or their families affected by natural or human-induced disasters/calamities
2. Bereavement assistance for deceased OWWA members
3. Disability assistance for OWWA members who were victims or accidents
4. Medical assistance for OWWA members who have illnesses, and who are not covered under MEDplus
5. Relief assistance to OWWA members who were displaced/laid-off due to economic/political situations in the jobsites.
