

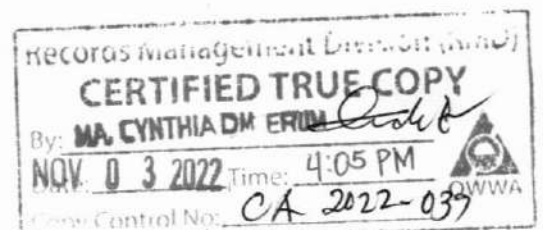
## CONTRACT AGREEMENT NO. 2022-32

THIS AGREEMENT made the \_\_\_\_\_ day of NOV 03 2022 2022 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** represented by its **Administrator ARNALDO A. IGNACIO** of OWWA Center Building cor. 7<sup>th</sup> Street and F.B. Harrison St., Pasay City, Philippines (hereinafter called "the Entity") of the one part and **CONTEL COMMUNICATIONS, INC.** represented by its **Finance and Corporate Head, Mr. THEODOSIUS SJ GONDRA** of 308 Sen. Gil Puyat Ave., Makati City (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for **Subscription of Seventeen (17) units Analog Trunked Radio Communication System for One (1) Year Subscription** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Two Hundred Twenty-five Thousand Eight Hundred Forty Pesos (Php225,840.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
  - (a) Purchase Request;
  - (b) Request for Price Quotation;
  - (c) Bid proposal, Eligibility requirements, documents and/or statements;
  - (d) Notice of Award of Contract and the Bidder's conforme thereto;
  - (e) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration for the sum of **Two Hundred Twenty-five Thousand Eight Hundred Forty Pesos (Php225,840.00)** inclusive of *initial payment of One (1) Month Subscription Fee for 17 Radios and Installation Cost and Repair for 9 Mobile Radios of Thirty-six Thousand Nine Hundred Seventy Pesos (Php36,970.00)* or such other sums as may be ascertained, **CONTEL COMMUNICATIONS, INC.** agrees to **Subscription of Seventeen (17) units Analog Trunked Radio Communication System for One (1) Year Subscription** in accordance with his/her/its Bid.
4. The **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.




