In consideration for the sum of Thirty-four Thousand Seven Hundred Twenty (Php34,720.00) per month or not to exceed the approved budget of Php173,600.00 or such other sums as may be ascertained, CONVERGE INFORMATION COMMUNICATIONS TECHNOLOGY SOLUTIONS INC. agrees to One (1) Lot - Provision of 20 Mbps Dedicated Internet Connection Services to the Overseas Workers Welfare Administration (OWWA) for National Reintegration Center for OFWs (NRCO) in Intramuros, Manila in accordance with his/her/its Bid.
- The OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA) agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


