

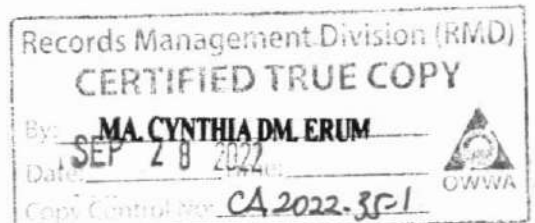
CONTRACT AGREEMENT NO. 2022-27

THIS AGREEMENT made the _____ day of SEP 28 2022 2022 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** represented by its **Administrator ARNALDO A. IGNACIO** of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines (hereinafter called "the Entity") of the one part and **NTT DATA PHILIPPINES, INC.** represented by its **President and CEO, Mr. POCHOLO S. REYES** of 28/F, 88 Corporate Center Sedenor cor. Valero Sts. Salcedo Village, Makati City, (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **One (1) Lot - Supply and Delivery of Various Developer IT Tools** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **One Hundred Thirty-nine Thousand Five Hundred Twenty-nine Pesos and 10/100 (Php139,529.10)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

 - (b) Request for Price Quotation;

 - (d) Notice of Award of Contract and the Bidder's conforme thereto;
 - (e) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration for the sum of **One Hundred Thirty-nine Thousand Five Hundred Twenty-nine Pesos and 10/100 (Php139,529.10)** or such other sums as may be ascertained, **NTT DATA PHILIPPINES, INC.** agrees to the **One (1) Lot - Supply and Delivery of Various Developer IT Tools** in accordance with his/her/its Bid.
4. The **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
