

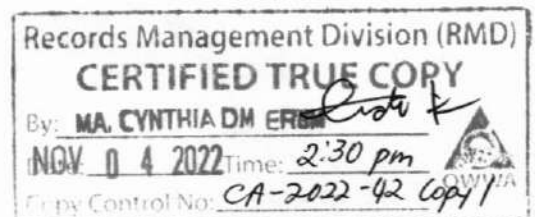
**CONTRACT AGREEMENT NO. 2022-28**



3. In consideration for the sum of **Two Hundred Twenty-four Thousand Pesos (Php224,000.00)** or such other sums as may be ascertained, **PEOPLE DYNAMICS, INC.** agrees to the **Supply and Delivery for the Purchase of 1,000 meters Online Assessment** in accordance with his/her/its Bid.
4. The **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
