

## Contract Agreement No. 2020-19

This AGREEMENT made this JAN 13 2021 day of \_\_\_\_\_ between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** represented by its Administrator **HANS LEO J. CACDAC**, OWWA Center Building cor. 7<sup>th</sup> Street and F.B. Harrison St., Pasay City, Philippines, hereinafter called the “Entity” of the one part and **NTT DATA PHILIPPINES, INC.** represented by its President and CEO, **POCHOLO S. REYES**, 88 Corporate Center Sedeno cor. Valero St., Salcedo Village, Makati City hereinafter called the “Supplier” of the other part.

  - (d) Notice of Award of Contract and the Bidder’s conforme thereto;
  - (e) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to execute and complete the goods and services and remedy any defects therein in conformity with the provisions of this Supplier in all respects.
4. The Entity hereby covenants to pay the Supplier in consideration of the execution and completion of the goods and services, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
