
Contract Agreement No. 2020-11


This AGREEMENT made this 20th day of JVH 2020 between OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA) represented by its Administrator HANS LEO J. CACDAC, OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines, hereinafter called "the Entity" of the one part and TANDEM ENGINEERING CONSULTANCY represented by its Proprietor CHRISTOPHER PAULO T. TAMAYO, 1504 D. Oliman St., Makati City hereinafter called "the Supplier" of the other part.

 - (d) Notice of Award of Contract and the Bidder's conforme thereto;
 - (e) Other contract documents that may be required by existing laws and/or the Client.
- 3. In consideration of the payments to be made by the Entity to the Supplier as hereir after mentioned, the Supplier hereby covenants with the Entity to provide the services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
- 4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
