

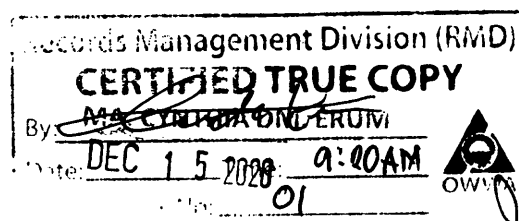
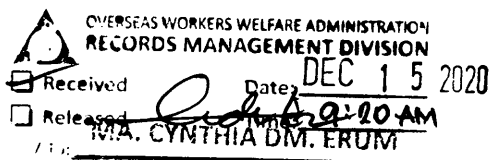
Contract Agreement No. 2020-11

This AGREEMENT made this 20th day of JULY 2020 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** represented by its Administrator **HANS LEO J. CACDAC**, OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines, hereinafter called "the **Entity**" of the one part and **TANDEM ENGINEERING CONSULTANCY** represented by its Proprietor **CHRISTOPHER PAULO T. TAMAYO**, 1504 D. Oliman St., Makati City hereinafter called "the **Supplier**" of the other part.

WHEREAS, the Entity invited Bids for **One (1) Lot – Provision of Structural Engineering Consultancy Services for CY 2020** and has accepted the bid by the Supplier for the services in the sum of **Three Hundred Thirty Four Thousand Pesos (Php334,000.00)** hereinafter called "the Contract Price".

NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and constructed as part of this Agreement, viz.:
 - (a) Terms of Reference;
 - (b) Request for Price Quotation;
 - (c) Eligibility requirements, documents and/or statements;
 - (d) Notice of Award of Contract and the Bidder's conforme thereto;
 - (e) Other contract documents that may be required by existing laws and/or the Client.
3. In consideration of the payments to be made by the Entity to the Supplier as hereir after mentioned, the Supplier hereby covenants with the Entity to provide the services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
