

Contract Agreement No. 2020-13

THIS AGREEMENT made this ____ day of **NOV 09 2020** 2020 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)**, represented by its Administrator **HANS LEO J. CACDAC**, of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines, hereinafter called the "**Entity**" of the one part and **AGD INFOTECH, INC.** represented by Account Manager-Data Center Infrastructure, **Ms. ERIKA V. DAILO**, of 1704 17/F Atlanta Centre, #31 Annapolis St. Greenhills, San Juan City hereinafter called the "**Supplier**" of the other part.

WHEREAS, the Entity invited Bids for the **Bidding Of One (1) Lot - Supply And Installation of Wifi Access Point & Structured Cabling with Network Management of OWWA Central Office** as specified in the Technical Specifications and has accepted a Bid by the **Supplier** for the sum of **One Million Seventy Nine Thousand Six Hundred Thirty One Pesos and 18/100 (Php1,079,631.18)** hereinafter called the "**Contract Price**".


NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:

3. In consideration of the payments to be made by the **Entity** to the **Supplier** as hereinafter mentioned, the **Supplier** hereby covenants with the **Entity** to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The **Entity** hereby covenants to pay the **Supplier** in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
