This AGREEMENT made this ~~09 DEC 2020~~ day of _____ between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** represented by its **Administrator HANS LEO J. CACDAC**, OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines, hereinafter called the "**Entity**" of the one part and **TIGER CONSULTING AND SOFTWARE DEV'T. INC.** represented by its **Managing Director, Mr. DENNIS LIM**, Unit 3A Pet Plans Tower, 444 EDSA Guadalupe Viejo, Makati City hereinafter called the "**Supplier**" of the other part.

3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to execute and complete the Subscription and remedy any defects therein in conformity with the provisions of this Supplier in all respects.
4. The Entity hereby covenants to pay the Supplier in consideration of the execution and completion of the Subscription, the Contract Price or such other sum as such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.




