
This AGREEMENT made this 27 day of 10 2020 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** represented by its **Administrator HANS LEO J. 3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to execute and complete the Subscription and remedy any defects therein in conformity with the provisions of this Supplier in all respects.
4. The Entity hereby covenants to pay the Supplier in consideration of the execution and completion of the Subscription, the Contract Price or such other sum as such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.


