
CONTRACT AGREEMENT NO. 2022-11

THIS AGREEMENT made the _____ day of APR 1 8 2022 2022 between OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA) represented by its Administrator HANS LEO J. CACDAC of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines (hereinafter called "the Entity") of the one part and JMC PEST MANAGEMENT represented by its Proprietor/Owner CAESAR M. TADIARCA of 30-A Mariveles St. Brgy. Sta. - The OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)
 agrees to pay the above-mentioned sum in accordance with the terms of
 the Bidding.
