

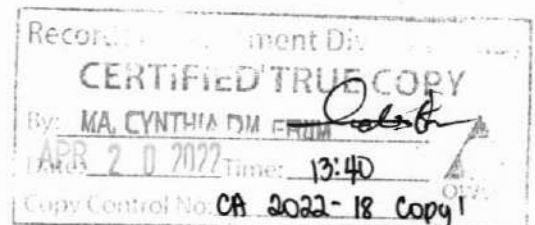
CONTRACT AGREEMENT NO. 2022-13

THIS AGREEMENT made the APR 18 2022 2022 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** represented by its **Administrator HANS LEO J. CACDAC** of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines (hereinafter called "the Entity") of the one part and **NANOTECH INTERNATIONAL LIFT SERVICES, INC.** represented by its **Authorized Managing Officer, Mr. RAMIL C. ACQUIATAN** of 46B Luzon St. Brgy. Central Signal Village, Taguig City (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly the **One (1) Lot - Preventive Maintenance of Elevators for Ten (10) Months for the period of March to December 2022, located at OWWA Central Office, Pasay City and DevCen Intramuros, Manila** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Four Hundred Sixty-four Thousand Pesos (Php464,000.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - (a) Terms of Reference;
 - (b) Request for Price Quotation;
 - (c) Eligibility requirements, documents and/or statements;
 - (d) Notice of Award of Contract and the Bidder's conforme thereto;
 - (e) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration for the sum of **Four Hundred Sixty-four Thousand Pesos (Php464,000.00)** or such other sums as may be ascertained, **NANOTECH INTERNATIONAL LIFT SERVICES, INC.** agrees to the **One (1) Lot - Preventive Maintenance of Elevators for Ten (10) Months for the period of March to December 2022, located at OWWA Central Office, Pasay City and DevCen Intramuros, Manila** in accordance with his/her/its Bid.
4. The **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

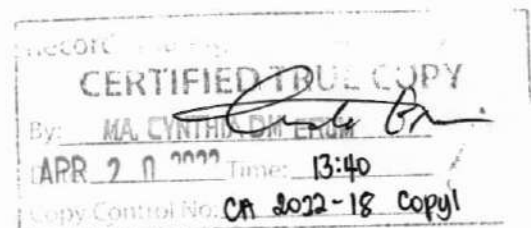
