
### CONTRACT AGREEMENT NO. 2022-13

THIS AGREEMENT made the APR 12 2022 between OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA) represented by its Administrator HANS LEO J. CACDAC of OWWA Center Building cor. 7th Street and F.B. - In consideration for the sum of Four Hundred Sixty-four Thousand Pesos (Php464,000.00) or such other sums as may be ascertained, NANOTECH INTERNATIONAL LIFT SERVICES, INC. agrees to the One (1) Lot -Preventive Maintenance of Elevators for Ten (10) Months for the period of March to December 2022, located at OWWA Central Office, Pasay City and DevCen Intramuros, Manila in accordance with his/her/its Bid.

  agrees to pay the above-mentioned sum in accordance with the terms of
  the Bidding.


