

CONTRACT RENEWAL AGREEMENT 2022-02

THIS AGREEMENT made the _____ day of **MAR 11 2022**, 2022 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** represented by its Administrator **HANS LEO J. CACDAC** of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines (hereinafter called "the Entity") of the one part and **CONVERGE INFORMATION COMMUNICATIONS TECHNOLOGY SOLUTIONS INC.** represented by its Unit Head Public Sector **Ms. EVANGELINE AGUINO** of Reliance Center Annex 1, 99 E. Rodriguez Jr. Ave., Brgy. Ugong, Pasig City (hereinafter called "the Supplier") of the other part.

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **One (1) Lot - Provision of 150-300 Mbps Dedicated internet Connection Services to the Overseas Workers Welfare Administration (OWWA) Central Office, Pasay City** and has accepted a Bid by the Supplier for the supply of those goods and services in the **Two Million three hundred ninety seven thousand three hundred thirty one and twenty centavos (Php2,397,331. 20)** (hereinafter called "the Contract Price") or **One Hundred Ninety-nine Thousand Seven Hundred Seventy-Seven Pesos and 60/100 (Php199,777.60) per month for 12 months** contract term from January – December 2022.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz. :
 - (a) Terms of Reference;
 - (b) Request for Price Quotation;
 - (c) Eligibility requirements, documents and/or statements;
 - (d) Notice of Award of Contract and the Bidder's conforme thereto;
 - (e) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration for the sum of **Two Million three hundred ninety seven thousand three hundred thirty one and twenty centavos (Php2, 397,331. 20)** or such other sums as may be ascertained, **CONVERGE INFORMATION COMMUNICATIONS TECHNOLOGY SOLUTIONS INC.** agrees to **One (1) Lot - Provision of 150-300 Mbps Dedicated Internet Connection Services to the Overseas Workers Welfare Administration (OWWA) Central Office, Pasay City** in accordance with his/her/its Bid.
4. The **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


