
CONTRACT AGREEMENT NO. 2022-19

THIS AGREEMENT made the _____ day of _____ 2022 between OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA) represented by its Administrator HANS LEO J. CACDAC of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines (hereinafter called "the Entity") of the one part and ISSI INFORMATION TECHNOLOGIES, INC. represented by its Account Executive, Ms. MARY GRACE CASINAS of Malaya Street, Marikina City (hereinafter called "the Supplier") of the other part;

- In consideration for the sum of Eighteen Thousand Eight Hundred Pesos (Php18,800.00) or Two Thousand Three Hundred Fifty Pesos (Php2,350.00) per unit per month or such other sums as may be ascertained, ISSI INFORMATION TECHNOLOGIES, INC. agrees to the Rental of Four (4) units Desktop Computer for the Period of Two (2) Months in accordance with his/her/its Bid.
- 4. The OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA) agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.




