

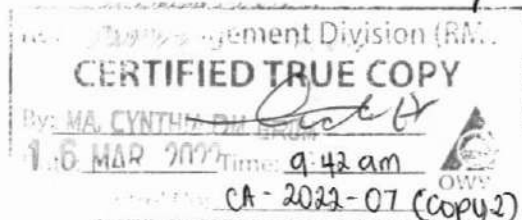
CONTRACT AGREEMENT NO. 2022-03

THIS AGREEMENT made the 14 day of MAR 14 2022 2022 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** represented by its Administrator **HANS LEO J. CACDAC** of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines (hereinafter called "the Entity") of the one part and **COMPUTECHNOLOGIES CORPORATION** represented by its Account Executive, **Ms. JULIE FIE V. TEJADA** of 33F Unit 3308 Robinsons Equitable Tower ADB Avenue corner Poveda St. Ortigas Center, Pasig City (hereinafter called "the Supplier") of the other part;


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - (d) Notice of Award of Contract and the Bidder's conforme thereto;
 - (e) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration for the sum of **Two Hundred Sixty-five Thousand Five Hundred Pesos (Php265,500.00)** or such other sums as may be ascertained, **COMPUTECHNOLOGIES CORPORATION** agrees to **One (1) Lot – Firewall License Renewal for One (1) Year** in accordance with his/her/its Bid.
4. The **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


