

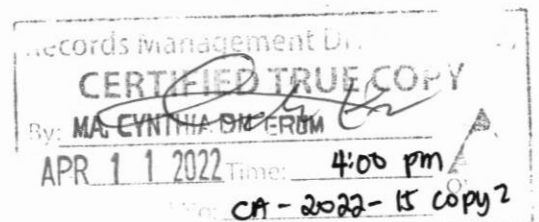
**CONTRACT AGREEMENT NO. 2022-05**

THIS AGREEMENT made the \_\_\_\_\_ day of APR 01 2022 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** represented by its Administrator **HANS LEO J. CACDAC** of OWWA Center Building cor. 7<sup>th</sup> Street and F.B. Harrison St., Pasay City, Philippines (hereinafter called "the Entity") of the one part and **H-ASIA NEWSPAPERS & MAGAZINES INC.** represented by its **President, Mr. HONESTO Y. VILLANUEVA** of Lot 3 F4 Omega Avenue, West Fairview, Quezon City (hereinafter called "the Supplier") of the other part;

  - (d) Notice of Award of Contract and the Bidder's conforme thereto;
  - (e) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration for the sum of **One Hundred Twenty-three Thousand Nine Hundred Forty-six Pesos and 50/100 (Php123,946.50)** or such other sums as may be ascertained, **H-ASIA NEWSPAPERS & MAGAZINES INC.** agrees to **One (1) Lot - Supply and Delivery of Newspapers** in accordance with his/her/its Bid.
4. The **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.




