
## CONTRACT AGREEMENT NO. 2022-08

THIS AGREEMENT made the <u>30th</u> day of <u>March</u> 2022 between OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA) represented by its Administrator HANS LEO J. CACDAC of OWWA Center Building cor. 7<sup>th</sup> Street and F.B. Harrison St., Pasay City, Philippines (hereinafter called "the Entity") of the one part and OS1 SOLUTIONS INC. represented by its Solutions Consultant, Ms. LHEA EDMA of #69 Roosevelt Ave. Parkwood Phase IA, Brgy. Maybunga, Pasig City (hereinafter called "the Supplier") of the other part;

- In consideration for the sum of Two Hundred Fifty-eight Thousand Pesos (Php258,000.00) or such other sums as may be ascertained, OS1 SOLUTIONS INC. agrees to One (1) Lot - Supply and Delivery of Endpoint Security System for 300 Users in accordance with his/her/its Bid.
- The OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA) agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
