

CONTRACT AGREEMENT NO. 2021-16

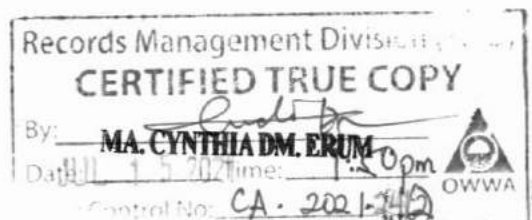

THIS AGREEMENT made the _____ day of _____ 2021 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** represented by its **Administrator HANS LEO J. CACDAC** of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines (hereinafter called "the Entity") of the one part and **NANOTECH INTERNATIONAL LIFT SERVICES INC.** represented by its **Operation Head Mr. RAMIL C. ACQUIATAN** of 46B Luzon St., Brgy. Central Signal Village, Taguig City (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly the **One (1) Lot – Preventive Maintenance of Elevators** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Four Hundred Fourteen Thousand Pesos (Php414,000.00)** (hereinafter called "the Contract Price").

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

 - (a) Terms of Reference;
 - (b) Request for Price Quotation;
 - (c) Eligibility requirements, documents and/or statements;
 - (d) Notice of Award of Contract and the Bidder's conforme thereto;
 - (e) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration for the sum of **Four Hundred Fourteen Thousand Pesos (Php414,000.00)** or such other sums as may be ascertained, **NANOTECH INTERNATIONAL LIFT SERVICES, INC.** agrees to the **One (1) Lot – Preventive Maintenance of Elevators** in accordance with his/her/its Bid.
4. The **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.



IN WITNESS whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.


