

CONTRACT AGREEMENT NO. 2021-21

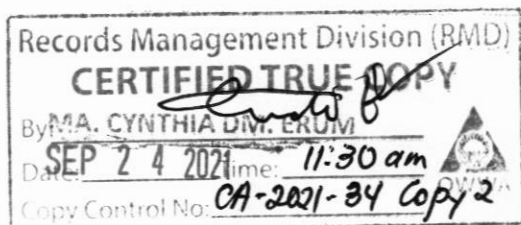

THIS AGREEMENT made the _____ day of _____ 2021 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** represented by its **Administrator HANS LEO J. CACDAC** of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines (hereinafter called "the Entity") of the one part and **CONVERGE INFORMATION COMMUNICATIONS TECHNOLOGY SOLUTIONS INC.** represented by its **Unit Head Public Sector Ms. EVANGELINE AGUINO** of Reliance Center Annex 1, 99 E. Rodriguez Jr. Ave., Bo. Ugong, Pasig City (hereinafter called "the Supplier") of the other part;

 - (a) Terms of Reference;
 - (b) Request for Price Quotation;
 - (c) Eligibility requirements, documents and/or statements;
 - (d) Notice of Award of Contract and the Bidder's conforme thereto;
 - (e) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration for the sum of **Nine Hundred Ninety-eight Thousand Eight Hundred Eighty-eight Pesos (Php998,888.00)** or such other sums as may be ascertained, **CONVERGE INFORMATION COMMUNICATIONS TECHNOLOGY SOLUTIONS INC.** agrees to **One (1) Lot - Provision of 150-300 Mbps Dedicated Internet Connection Services to the Overseas Workers Welfare Administration (OWWA) Central Office, Pasay City** in accordance with his/her/its Bid.
4. The **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
