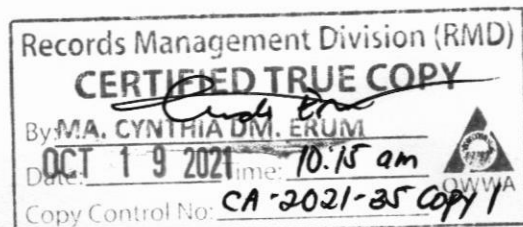
THIS AGREEMENT made the _____ day of _____ 2021 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** represented by its **Administrator HANS LEO J. CACDAC** of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines (hereinafter called "the Entity") of the one part and **NTT DATA PHILIPPINES INC.** represented by its **President and CEO, Mr. POCHOLO S. 3. In consideration for the sum of **One Hundred Nineteen Thousand Three Hundred One Pesos and 33/100 (Php119,301.33)** or such other sums as may be ascertained, **NTT DATA PHILIPPINES INC.** agrees to **Supply and Delivery of Various IT Tools** in accordance with his/her/its Bid.
4. The **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
