

CONTRACT AGREEMENT NO. 2023-12


THIS AGREEMENT made the _____ day **APR 03 2023** 2023 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** represented by its **Administrator ARNALDO A. IGNACIO** of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines (hereinafter called "the Entity") of the one part and **JMC PEST MANAGEMENT** represented by its **Proprietor/Owner, Mr. CAESAR M. TADIARCA** of 30-A Mariveles St. Brgy. Sta. Teresita, Quezon City (hereinafter called "the Supplier") of the other part;


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

4. The **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
