
### CONTRACT AGREEMENT NO. 2023-13

- In consideration for the sum of Four Hundred Thousand Pesos (Php400,000.00) or such other sums as may be ascertained, FORTNITE INDUSTRIAL EQUIPMENT CORP, agrees to Proposal for the Preventive Maintenance of Elevators for Ten (10) Months located at OWWA Central Office, Pasay City and DevCen Intramuros, Manila for the period of March 2023 to December 2023 in accordance with his/her/its Bid.
- The OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)
  agrees to pay the above-mentioned sum in accordance with the terms of
  the Bidding.


