


CONTRACT AGREEMENT NO. 2023-15

THIS AGREEMENT made the 24th day of April 2023 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** represented by its **Administrator ARNALDO A. IGNACIO** of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines (hereinafter called "the Entity") of the one part and **COMPUTECHNOLOGIES CORPORATION** represented by its **Account Executive, Ms. JULIE FIE V. 
NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
