

CONTRACT AGREEMENT NO. 2023-02

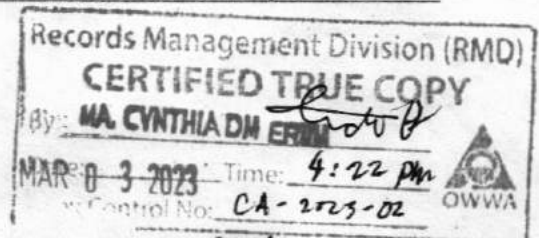
THIS AGREEMENT made the _____ day of _____ 2023 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** represented by its **Administrator ARNALDO A. IGNACIO** of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines (hereinafter called "the Entity") of the one part and **LIFEGUARD GABRIEL SECURITY AGENCY CORPORATION** represented by its **President and General Manager, Mr. ROCINIAN B. GECOSALA** of Unit 2-1 Maxsalome Condo., 457 Barangka Drive, Mandaluyong City (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Bidding for the Provision of Security Services for OWWA Central Office for FY 2023** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Twenty-three Million Four Hundred Seventy-six Thousand Three Hundred Ninety-seven Pesos and 6/100 (Php23,476,397.06)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.



3. In consideration for the sum of *Twenty-three Million Four Hundred Seventy-six Thousand Three Hundred Ninety-seven Pesos and 6/100 (Php23,476,397.06)* or such other sums as may be ascertained, **LIFEGUARD GABRIEL SECURITY AGENCY CORPORATION** agrees to **Provision of Security Services for OWWA Central Office for FY 2023** in accordance with his/her/its Bid.
4. The **OVERSEAS WORKERS WELFARE ADMINISTRATION** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
