

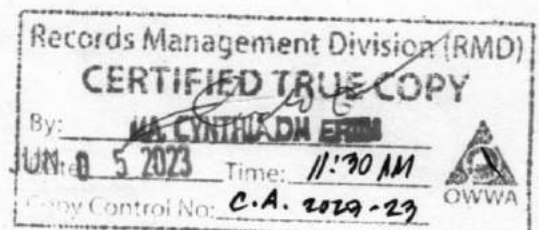
CONTRACT AGREEMENT NO. 2023-18

THIS AGREEMENT made the 02 day of June 2023 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** represented by its Administrator **ARNALDO A. IGNACIO** of OWWA Center Building cor. 7th Street and F.B. 
NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

In consideration for the sum of **One Hundred Sixty-four Thousand Six Hundred Ten Pesos (Php164,610.00)** or such other sums as may be ascertained, **H-ASIA NEWSPAPERS & MAGAZINES INC.** agrees to **One (1) Lot – Supply and Delivery of Newspapers Subscription (tabloids and broadsheets)** in accordance with his/her/its Bid.
4. The **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
