In consideration for the sum of One Million Two Hundred Twenty Thousand Three Hundred Sixty-five Pesos and 92/100 (Php1,220,365.92) or such other sums as may be ascertained, BLUE CHIP MARKETING agrees to Rebidding for Courier Services for OWWA's Official Mails and Parcel Delivery for Overseas Destinations in accordance with his/her/its Bid.
- 4. The **OVERSEAS WORKERS WELFARE ADMINISTRATION** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
