
CONTRACT AGREEMENT NO. 2023-03

THIS AGREEMENT made the ______ day &PR 20 2023 2023 between OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA) represented by its Administrator ARNALDO A. IGNACIO of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines (hereinafter called "the Entity") of the one part and CONVERGE INFORMATION COMMUNICATIONS TECHNOLOGY SOLUTIONS INC. represented by its Unit Head Corporate Sales Ms. EVANGELINE AQUINO of Reliance Center Annex 1, 99 E.  - (e) Other contract documents that may be required by existing laws and/or the Entity.
- In consideration for the sum of One Hundred Ninety-nine Thousand Seven Hundred Seventy-seven Pesos and 60/100 (Php199,777.60) per month or not to exceed the approved budget of Php2,397,331.20.00 or such other sums as may be ascertained, CONVERGE INFORMATION COMMUNICATIONS TECHNOLOGY SOLUTIONS INC. agrees to One (1) Lot - Provision of 150-300Mbps Dedicated Internet Connection Services to the Overseas Workers Welfare Administration (OWWA) in accordance with his/her/its Bid.
- The OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)
 agrees to pay the above-mentioned sum in accordance with the terms of
 the Bidding.


