
CONTRACT AGREEMENT NO. 2023-04

THIS AGREEMENT made the ______ day of <u>MAR 1 7 2023</u> 2023 between OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA) represented by its Administrator ARNALDO A. IGNACIO of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines (hereinafter called "the Entity") of the one part and MYBUSYBEE INC. represented by its Chief Executive Officer/Founder Mr. RICO M. HERNANDEZ of Unit 7 G/F Burgundy Place 174-B, Gonzales St., Loyola Heights, Quezon City (hereinafter called "the Supplier") of the other part;

- In consideration for the sum of One Hundred Twenty Thousand Pesos (Php120,000.00) or such other sums as may be ascertained, MYBUSYBEE INC. agrees to Supply and Delivery of 10 host Online Video Conference for One (1) Year in accordance with his/her/its Bid.
- The OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA) agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.




