

CONTRACT AGREEMENT NO. 2023-06

THIS AGREEMENT made the MAR 22 2023 day of _____ 2023 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** represented by its **Administrator ARNALDO A. IGNACIO** of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines (hereinafter called "the Entity") of the one part and **ADSPARK, INC.** represented by its OIC-COO, **Mr. JOHN LOUIE ERESTAIN** of 11F W City Center Lane Q, Bonifacio Global City, Taguig (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **One (1) Lot - Supply and Delivery of SMS Gateway** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Two Hundred Forty Thousand Pesos (Php240,000.00)** (hereinafter called "the Contract Price").

 - (e) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration for the sum of **Two Hundred Forty Thousand Pesos (Php240,000.00)** or such other sums as may be ascertained, **ADSPARK, INC.** agrees to **One (1) Lot - Supply and Delivery of SMS Gateway** in accordance with his/her/its Bid.
4. The **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


