CONTRACT AGREEMENT NO. 2023-22

THIS AGREEMENT made the <u>Ith</u> day of <u>JMC</u> 2023 between OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA) represented by its Administrator ARNALDO A. IGNACIO of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines (hereinafter called "the Entity") of the one part and JOEBZ COMPUTER SALES AND SERVICES represented by its Proprietress, Ms. RHODORA R. CUAJAO of Brgy. 14, Salazar St., Tacloban City (hereinafter called "the Supplier") of the other part;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees</u> that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the <u>Contract.</u>

In consideration for the sum of One Million Five Hundred Fifty-eight Thousand Seven Hundred Eighty-four Pesos (Php1,558,784.00) or such other sums as may be ascertained, JOEBZ COMPUTER SALES AND SERVICES agrees to Bidding for One (1) Lot – Supply, Delivery and Installation of LED Wall Monitors in accordance with his/her/its Bid.
- The OVERSEAS WORKERS WELFARE ADMINISTRATION agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
