



CONTRACT AGREEMENT NO. 2023-32

THIS AGREEMENT made the 12 day 2023 2023 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** represented by its **Administrator ARNALDO A. IGNACIO** of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines (hereinafter called "the Entity") of the one part and **PEOPLE DYNAMICS, INC.** represented by its **Director, HR/OD Special Projects, Ms. MARIA VICTORIA T. ESTACIO** of U502 OMM-Citra Bldg., 39 San Miguel Ave., Ortigas Center, Pasig City (hereinafter called "the Supplier") of the other part;

3. In consideration for the sum of **Two Hundred Twenty-four Thousand Pesos (Php224,000.00)** or such other sums as may be ascertained, **PEOPLE DYNAMICS, INC.** agrees to the **Proposal for 1,000 meters Purchase of Online Assessment** in accordance with his/her/its Bid.
4. The **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.






