
CONTRACT AGREEMENT NO. 2023-35

THIS AGREEMENT made the 24th day of october 2023 between OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA) represented by its Administrator ARNALDO A. IGNACIO of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines (hereinafter called "the Entity") of the one part and Facilitator/Resource Person, Ms. PAZ RESURRECCION M. ALIP of 38 Sta. ALIP agrees to Proposal for One (1) Lot Procurement of Facilitator/Resource Person Services for the Training of Trainor's for the PDOS Providers in accordance with his/her/its Bid.
- The OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)
 agrees to pay the above-mentioned sum in accordance with the terms of
 the Bidding.




