

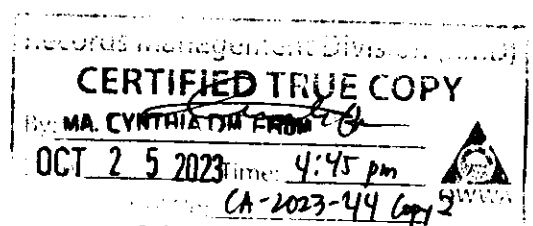
CONTRACT AGREEMENT NO. 2023-35

THIS AGREEMENT made the 24th day of October 2023 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** represented by its **Administrator ARNALDO A. IGNACIO** of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines (hereinafter called "the Entity") of the one part and **Facilitator/Resource Person, Ms. PAZ RESURRECCION M. ALIP** of 38 Sta. Maria St. Kapitolyo, Pasig City (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly the **Proposal for One (1) Lot - Procurement of Facilitator/Resource Person Services for the Training of Trainor's for the PDOS Providers** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Fifty Thousand Pesos (Php50,000.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - (a) Terms of Reference;
 - (b) Request for Price Quotation;
 - (c) Eligibility requirements, documents and/or statements;
 - (d) Notice of Award of Contract and the Bidder's conforme thereto;
 - (e) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration for the sum of **Fifty Thousand Pesos (Php50,000.00)** or such other sums as may be ascertained, **PAZ RESURRECCION M. ALIP** agrees to **Proposal for One (1) Lot - Procurement of Facilitator/Resource Person Services for the Training of Trainor's for the PDOS Providers** in accordance with his/her/its Bid.
4. The **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


