
CONTRACT AGREEMENT NO. 2023-37

THIS AGREEMENT made the 101 2 3 day of ________ 2023 between OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA) represented by its Administrator ARNALDO A. IGNACIO of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines (hereinafter called "the Entity") of the one part and COMMERCE ASIA INC. represented by its Sales Manager, Ms. MICHELLE V. - The OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)
 agrees to pay the above-mentioned sum in accordance with the terms of the
 Bidding.


