

 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees</u> <u>that additional contract documents or information prescribed by</u> <u>the GPPB that are subsequently required for submission after the</u> <u>contract execution, such as the Notice to Proceed, Variation</u> <u>Orders, and Warranty Security, shall likewise form part of the</u> <u>Contract.</u>



- In consideration for the sum of *Two Million Pesos (Php2,000,000.00)* or such other sums as may be ascertained, SUPER-AIRE REFRIGERATION & CONTRACTORS, INC. agrees to Rebidding for One (1) Lot – Supply, Delivery and Installation of Air-conditioning Units in accordance with his/her/its Bid.
- The OVERSEAS WORKERS WELFARE ADMINISTRATION agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


