

CONTRACT AGREEMENT NO. 2023-27

THIS AGREEMENT made the _____ day of SEP 15 2023 2023 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** represented by its **Administrator ARNALDO A. IGNACIO** of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines (hereinafter called "the Entity") of the one part and **VERSA INNOVATIONS CORP.** represented by its **Business Development Head, Mr. JULIUS VICTOR L. MEDALLA** of No. 35 Liberty Ave. cor. 9th Ave. Brgy. Socorro, Cubao, Quezon City (hereinafter called "the Supplier") of the other part;

In consideration of Twenty-nine Thousand Nine Hundred Eighty Pesos (**Php29,980.00**) *one-time payment* and Nine Thousand Nine Hundred Eighty Pesos (**Php9,980.00**) for *monthly subscription* or a total sum of **One Hundred Thirty-nine Thousand Seven Hundred Sixty Pesos (Php139,760.00)** for twelve (12) months inclusive of such other sums as may be ascertained, **VERSA INNOVATIONS CORP.** agrees to **One (1) Lot - Subscription of 4G LTE Two Way Radio for OWWA Central Office** in accordance with his/her/its Bid.
4. The **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.






