

CONTRACT AGREEMENT NO. 2024-10

THIS AGREEMENT made the _____ day 17 of APR 2024 2024 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** represented by its **Administrator ARNALDO A. IGNACIO** of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines (hereinafter called "the Entity") of the one part and **W. SIA PEST CONTROL SERVICES** represented by its **Admin Officer, Ms. MC LORRAINE C. VENTURA** of 558 Cavite St., Gagalangin, Tondo, Manila (hereinafter called "the Supplier") of the other part;

SIA PEST CONTROL SERVICES** agrees to **Proposal for One (1) Lot - Supply of Labor and Materials for the application of PEST CONTROL weekly from March to December 2024** in accordance with his/her/its Bid.
4. The **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

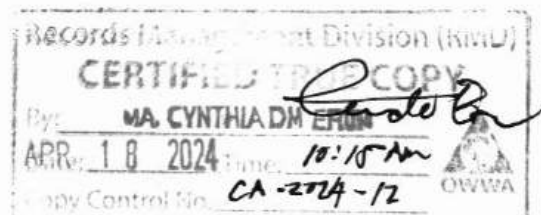


