

CONTRACT AGREEMENT NO. 2024-11

THIS AGREEMENT made the _____ day of _____ 2024 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** represented by its **Administrator ARNALDO A. IGNACIO** of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines (hereinafter called "the Entity") of the one part and **SKY CABLE CORPORATION** represented by its **Consumer LOB Head & Head CPPAG, Mr. JAMES A. DUMLAO** of 6/F ELJ Communication Center Eugenio Lopez Drive, Quezon City (hereinafter called "the Supplier") of the other part;

 - (e) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration for the sum of **Six Hundred Ninety-four Thousand Pesos (Php694,000.00)** or such other sums as may be ascertained, **SKY CABLE CORPORATION** agrees to **One (1) Lot - Provision of 100 Mbps Dedicated Internet Connection Services to the OFW Lounge at NAIA Terminal 1, Pasay City** for One (1) Year in accordance with his/her/its Bid.
4. The **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
