

## CONTRACT AGREEMENT NO. 2024-12


THIS AGREEMENT made the \_\_\_\_\_ day of APR 22, 2024 2024 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** represented by its **Administrator ARNALDO A. IGNACIO** of OWWA Center Building cor. 7<sup>th</sup> Street and F.B. Harrison St., Pasay City, Philippines (hereinafter called "the Entity") of the one part and **A.C. 
NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

ONG CONSULTING INC.** agrees to **Proposal for the Provision of Structural Engineering Consultancy Services for the period of March to December 2024** in accordance with his/her/its Bid.
4. The **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
