
## CONTRACT AGREEMENT NO. 2024-13

THIS AGREEMENT made the \_\_\_\_ day of \_\_\_\_ 2024 between OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA) represented by its Administrator ARNALDO A. IGNACIO of OWWA Center Building cor. 7<sup>th</sup> Street and F.B. Harrison St., Pasay City, Philippines (hereinafter called "the Entity") of the one part and POWERLIFT ELEVATOR & ESCALATOR CORP. represented by its Manager - Service Department, Mr. EDGAR C. DELA PUNTA of 21 Lancer St. Village East, Exec. Village, Cainta, Rizal (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly the Proposal for Preventive Maintenance of Elevators located at OWWA Central Office, Pasay City and DevCen Intramuros, Manila for the period of March 1, 2024 to December 31, 2024 and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Nine Hundred Eighty-four Thousand Pesos (Php984,000.00) (hereinafter called "the Contract Price").

  - (d) Notice of Award of Contract and the Bidder's conforme thereto;
  - (e) Other contract documents that may be required by existing laws and/or the Entity.
- In consideration for the sum of Nine Hundred Eighty-four Thousand Pesos (Php984,000.00) or Ninety-eight Thousand Four Hundred Pesos (Php98,400.00) per month and such other sums as may be ascertained, POWERLIFT ELEVATOR & ESCALATOR CORP. agrees to Proposal for Preventive Maintenance of Elevators located at OWWA Central Office, Pasay City and DevCen Intramuros, Manila for the period of March 1, 2024 to December 31, 2024 in accordance with his/her/its Bid.
- The OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)
  agrees to pay the above-mentioned sum in accordance with the terms of
  the Bidding.
