

CONTRACT AGREEMENT NO. 2024-16

THIS AGREEMENT made the _____ day of 29 JUL 2024 2024 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** represented by its **Administrator ARNALDO A. IGNACIO** of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines (hereinafter called "the Entity") of the one part and **SKY CABLE CORPORATION** represented by its **Business Unit Head, RODERICK U. LIWANAG** of 6/F ELJ Communication Center Eugenio Lopez Drive, Quezon City (hereinafter called "the Supplier") of the other part;

 - (e) Other contract documents that may be required by existing laws and/or the Entity.

In consideration of *Two Thousand Pesos (Php2,000.00) one-time payment and Five Thousand Six Hundred Twenty-five Pesos (Php5,625.00) for a monthly subscription* or a total sum of **Forty-seven Thousand Pesos (Php47,000.00)** or such other sums as may be ascertained, **SKY CABLE CORPORATION** agrees to **One (1) Lot – Subscription of Cable Television for Ten (10) Outlets at OWWA Center Building for the period of CY 2024** in accordance with his/her/its Bid.
4. The **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
