

CONTRACT AGREEMENT NO. 2024-03

THIS AGREEMENT made the **MAR 21 2024** day of _____ 2024 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** represented by its **Administrator ARNALDO A. IGNACIO** of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines (hereinafter called "the Entity") of the one part and **CONVERGE INFORMATION COMMUNICATIONS TECHNOLOGY SOLUTIONS INC.** represented by its **Unit Head Corporate Sales Ms. EVANGELINE AQUINO** of Reliance Center Annex 1, 99 E. Rodriguez Jr. Ave., Bo. Ugong, Pasig City (hereinafter called "the Supplier") of the other part;


WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **One (1) Lot - Provision of 10Mbps Dedicated Internet Connection Services to the Overseas Workers Welfare Administration (OWWA) - MPC POEA** for One (1) Year and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Two Hundred Fifty Thousand Three Hundred Eighty-seven Pesos and 20/100 (Php250,387.20)** (hereinafter called "the Contract Price").

 - (c) Eligibility requirements, documents and/or statements;
 - (d) Notice of Award of Contract and the Bidder's conforme thereto;
 - (e) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration for the sum of **Two Hundred Fifty Thousand Three Hundred Eighty-seven Pesos and 20/100 (Php250,387.20)** or such other sums as may be ascertained, **CONVERGE INFORMATION COMMUNICATIONS TECHNOLOGY SOLUTIONS INC.** agrees to **One (1) Lot - Provision of 10Mbps Dedicated Internet Connection Services to the Overseas Workers Welfare Administration (OWWA) - MPC POEA** in accordance with his/her/its Bid.
4. The **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.




