
CONTRACT AGREEMENT NO. 2024-03

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly One (1) Lot - Provision of 10Mbps Dedicated Internet Connection Services to the Overseas Workers Welfare Administration (OWWA) - MPC POEA for One (1) Year and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Two Hundred Fifty Thousand Three Hundred Eightyseven Pesos and 20/100 (Php250,387.20) (hereinafter called "the Contract Price").

- The OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)
 agrees to pay the above-mentioned sum in accordance with the terms of
 the Bidding.


