
CONTRACT AGREEMENT NO. 2024-04

THIS AGREEMENT made the <u>18th</u> day of <u>March</u> 2024 between OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA) represented by its Administrator ARNALDO A. IGNACIO of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines (hereinafter called "the Entity") of the one part and H-ASIA NEWSPAPERS & MAGAZINES INC. represented by its President & CEO, Mr. HONESTO Y. VILLANUEVA of Lot 3 F4 Omega Avenue, West Fairview, Quezon City (hereinafter called "the Supplier") of the other part;

- In consideration for the sum of Five Hundred Four Thousand Three Hundred Eighty-six Pesos (Php504,386.00) or such other sums as may be ascertained, H-ASIA NEWSPAPERS & MAGAZINES INC. agrees to One (1) Lot - Supply and Delivery of Newspapers Subscription (tabloids and broadsheet) for the period of March to December 2024 in accordance with his/her/its Bid.
- The OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA) agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
