



CONTRACT AGREEMENT NO. 2024-05

THIS AGREEMENT made the 04 day of April 2024 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** represented by its **Administrator ARNALDO A. IGNACIO** of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines (hereinafter called "the Entity") of the one part and **ESCO PTE LTD** represented by its **Account Manager, Mr. LESTER KATE SOTTO** of Unit 2601 26/F Antel 2000 Corporate Center, Valero St., Salcedo Village, Makati City (hereinafter called "the Supplier") of the other part;

3. In consideration for the sum of **One Hundred Thirty Thousand Nine Hundred Two pesos and 25/100 (Php130,902.25)** or such other sums as may be ascertained, **ESCO PTE LTD** agrees to **Supply and Delivery of Online Video Conference** in accordance with his/her/its Bid.
4. The **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.




