
### CONTRACT AGREEMENT NO. 2024-06

IGNACIO of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines (hereinafter called "the Entity") of the one part and DACO SALES CORPORATION represented by its President, Ms. JOANNA T. YONG LOOK of No. 5 Felix Manalo St. Brgy. Pinagkaisahan Cubao, Quezon City (hereinafter called "the Supplier") of the other part;

  - (e) Other contract documents that may be required by existing laws and/or the Entity.
- In consideration for the sum of Three Hundred Sixty-nine Thousand Three Hundred twenty-five Pesos (Php369,325.00) or such other sums as may be ascertained, DACO SALES CORPORATION agrees to One (1) Lot - Supply and Delivery of Purified Drinking Water for the period of Eleven (11) months from February 2024 to December 2024 in accordance with his/her/its Bid.
- The OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)
  agrees to pay the above-mentioned sum in accordance with the terms of
  the Bidding.


