

CONTRACT AGREEMENT NO. 2024-08

THIS AGREEMENT made the _____ day of _____ 2024 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** represented by its **Administrator ARNALDO A. IGNACIO** of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines (hereinafter called "the Entity") of the one part and **VERSA INNOVATIONS CORP.** represented by its **Business Development Head, Mr. JULIUS VICTOR L. MEDALLA** of No. 35 Liberty Ave. cor. 9th Ave. Brgy. Socorro, Cubao, Quezon City (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for **One (1) Lot - Subscription of 4G LTE Two Way Radio for OWWA Central Office** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Two **Hundred Seventy-nine Thousand Five Hundred Twenty Pesos (Php279,520.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

 - (d) Notice of Award of Contract and the Bidder's conforme thereto;
 - (e) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of Forty Thousand Pesos (**Php40,000.00**) *one-time payment* and Nineteen Thousand Nine Hundred Sixty Pesos (**Php19,960.00**) for *monthly subscription* or a total sum of **Two Hundred Seventy-nine Thousand Five Hundred Twenty Pesos (Php279,520.00)** for twelve (12) months inclusive of such other sums as may be ascertained, **VERSA INNOVATIONS CORP.** agrees to **One (1) Lot - Subscription of 4G LTE Two Way Radio for OWWA Central Office** in accordance with his/her/its Bid.
4. The **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.






