

**CONTRACT AGREEMENT NO. 2024-36**

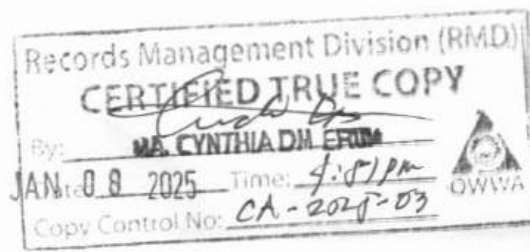

  - (e) Other contract documents that may be required by existing laws and/or the Entity.

In consideration for the sum of **Three Hundred Twenty-four Thousand Pesos (Php324,000.00)** or such other sums as may be ascertained, **AGMS INFORMATION TECHNOLOGY INC.** agrees to **Subscription of Web Application Firewall (WAF) and Anti-Distributed Denial of Service (ANTI-DDOS) Protection** in accordance with his/her/its Bid.
4. The **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


